**Subject: - Guidelines on transparency and accountability in party funds and election expenditure-submission of reports by unrecognized political parties-regarding.**

Sir,

On the subject cited above, I am directed to inform you that the following periodical reports in respect of your respective Registered Unrecognized Political Party (RUPP) for the financial years, 2022-23, 2023-24 and 2024-25 (as per list enclosed) have not received in this office till date. Whereas, these are mandatorily required to be forwarded to the concerned Chief Electoral Officer, in which State the Party Headquarter is located as per the standing instructions of the Election Commission of India.

1.	Contribution Reports -30 <sup>th</sup> September every year or such date, as extended by CBDT, for filing Income Tax Return	Only on Commission's prescribed Form 24A
2.	Annual Audited Account Reports – 31 <sup>st</sup> October every year.	These accounts invariably be audited by the qualified and practicing Chartered Accountants as per the norms of the ECI
3.	Statement of election expenditure – within 75 days of completion of Assembly Election and 90 days of completion of Lok Sabha Election. <b><u>If election contested by the candidates set up by the RUPPs</u></b>	This statement shall be submitted only by those RUPPs whose candidates have contested the Lok Sabha Election and Bye Election to Assembly Constituencies -2024

You are, therefore, requested to send the above mentioned documents with respect to your political party to this department immediately.

Further the list of RUPPs who have submitted/not submitted contribution reports, Annual Audited Accounts and Election Expenditure report to this office is also enclosed herewith for your information and further necessary action please.
